# Secretary's Report - Paul Silver

The January 2018 meeting minutes were approved as amended.

During January the following motion was conducted via email:

# Vice President's Report - Brett Litoff

### Treasurer's Report - Ryan Moore

Ryan presented the monthly financial report. He has purchased replacement checks and a new checkbook for the club at a cost of \$112. The track deposit for the Buttonwillow HPDE has been paid. He has made the club's property tax payment and has been working on advertising invoices. - **Volunteer of the Year Presentation** Lisa presented the Volunteer of the Year award to Brett Litoff.
- **Housekeeping** We received a request last month from the National DEC chair to provide samples of waivers from Driving Events for the past three years. Discussions were held on maintenance of waiver records and board email discussions.
- Holiday Party Follow Up Emily indicates that BMW of San Diego would be willing to provide the
  dealership space for the Holiday Party, suggested we survey membership as to what they want in a
  Holiday Party, and volunteered to administer the survey. Dan Tackett suggested moving the Holiday
  party to January and combining it with the Board elections to get more members involved.
- La Jolla Motor Car Classic Follow Up Dennis did not receive any interest from regular Clean Car Show regulars in participating.
- **Committees** Volunteers are requested for the Strategic Planning committee. Ryan, Brett, and Ed volunteered to participate.
- Charity Matching Funds Dennis Damon reported that he submitted the Chapter's 2017 charity donations to the BMW CCA National office and described how the Matching Funds program works. The CCA matches funds donated to charities, and awards chapters with the largest donations.

## **Buttonwillow Driving Event - Seth Hanson**

Seth is working on updating the budget, and we are currently below break-even on the event. 40 students are signed up for the school, 4 students for the racing school, 13 people for Time Trial (including 8 instructors), and 6 for advanced data analysis. 40 instructors have committed to the event. We need about 5 more students to break even. Central Cal chapter is hosting an event at Buttonwillow Friday October 26 and requested our

assistance regarding MotorsportsReg, registration, and student & instructor packets. We need clarification on whether they want to use our MotorsportReg account or assistance with their own.

#### **Autocross - Kim Schwarz**

We have an autocross in the Southeast lot March 10 and a Car Control Clinic and autocross practice on April 21. We are not doing a points series this year. The January autocross went well and made \$1939.

## **Performance Center Event Recap - Dan Tackett**

The event sold out within 3 weeks after registration opened in September 2017. We had 104 participants. The event made a profit of about \$1000. **MOTION** by Dan Tackett and seconded to sign the contract for a Performance Center event to be held Saturday January 26, 2019 with 50% of \$19,890 due 60 days in advance of the event and the balance due 30 days before the event. Motion passed.
