# Autocross - Greg Uhler

- **General update** The last autocross was successful in terms of the event, participation, and volunteers. It was a fun day. However, participation was lower than the last event, and we lost approximately \$631 on the event.
- **Upcoming and changed dates** There is a conflict with the venue for the August date, so we are pushing this out to September 9. Because the October date would have been too soon after this, the October 15 event has been cancelled.
- Truck & Trailer Discussion A suggestion was made to replace the trailer with a Sprinter van or to place a cargo container at the autocross venue to hold most of the equipment. Based on email feedback received, the container idea is not viable due to being difficult to transport equipment to other sites, should we host an autocross at another location. A discussion ensued on the pros and cons of the Sprinter van. Greg will do a financial analysis, taking into account the cost of a van and the value of our truck and trailer, to see if this is a feasible option.

• **Update from last Communications team meeting** – The Communications team met on June 20 and discussed event RSVPs on Facebook vs. requesting RSVPs by email.
